DEVELOPMENT OVERVIEW

W I-40 Industrial Park is a new Class A development featuring two rear-load buildings with frontage along I-40. Located less than 1/2 mile from the I-40/Morgan Rd. interchange and approximately ten miles from I-35 (USMCA corridor), the property offers seamless access to key transportation routes and logistical networks. Strategically located just 15 minutes from Will Rogers International Airport, the site provides unmatched connectivity to Oklahoma City's major transportation arteries. The I-40 corridor is one of the busiest in the region, with nearly 150,000 vehicles per day - approximately 25% of which are semi trucks - making it ideal for distribution, warehousing and manufacturing operations.

The intersection at I-40 and Morgan Rd. features a Single Point Urban Interchange (SPUI), a highly efficient traffic design that allows all directions of traffic to move through a single centralized signal. This setup minimizes congestion and maximizes flow, further enhancing the site's accessibility for freight and employee traffic.


